Rule 56.1 (a 56.1 statement). • In the 56.1 statement, the moving party must list, in individually numbered paragraphs, important facts that the party argues are not in dispute. • To oppose a motion for summary judgment, in addition to a memorandum of law, you must submit your own statement responding to the other party’s 56.1 statement.
